

- 2. Sponsorship Benefits.**
 - a. In consideration of Company's payment of the Sponsorship Fee, Wellvana Health, LLC will provide Company with the benefits detailed (for the sponsorship level(s) and additional options selected by Company) on the Conference Sponsorship Options attachment (collectively, the "Sponsorship Benefits"), as applicable.

 - d. - 4. License Grant.**
 - a. Wellvana Health, LLC hereby grants to Company, and Company hereby accepts, a non-exclusive, non-transferable, non-sublicensable right and license to use the Wellvana Health, LLC Marks, during the Term, as necessary to:
 - i. receive the Sponsorship Benefits;
 - ii. in its advertising, marketing, and promotional materials in all formats and media, including on its website, mobile apps, and social marketing pages on third-party websites and mobile apps, to identify and promote its association with and its status as a sponsor of the Event; and
 - iii. on Event collateral that Company is obligated or otherwise permitted to create and distribute at or in connection with the Event;
 - b. Company hereby grants to Wellvana Health, LLC, and Wellvana Health, LLC hereby accepts, a non-exclusive, non-transferable, non-sublicensable right and license to use the Company Marks, during the Term, as necessary to:
 - i. provide the Sponsorship Benefits;
 - ii. in its advertising, marketing, and promotional materials in all formats and media, including on its website, mobile apps, and social marketing pages on third-party websites and mobile apps, to identify and promote Company's association with and its status as a sponsor of the Event; and
 - iii. on Event collateral and materials created by Wellvana Health, LLC.
 - c. Each party shall submit examples of all proposed uses of the other party's Marks to the other party for written approval, provided that any failure of a party to object in writing to any proposed use within two (2) weeks of the initial submission for approval shall be deemed an approval of the proposed use.
 - d. Each party shall use the other party's Marks solely in accordance with the other party's intellectual property usage guidelines and quality control standards (if provided), as the same may be updated from time to time. Neither party shall use, register, or attempt to register in any jurisdiction any Marks that are confusingly similar to or incorporate any of the other party's Marks. All uses of a party's Marks and all goodwill associated therewith shall inure solely to the benefit of such party, and each party shall retain, all title, right, and interest in and to its Marks.
- 5. Code of Conduct.** The Event is an educational conference for healthcare professionals and leaders. All business and promotional activities must be confined to Company's designated exhibit space. In keeping with the nature of a health care professional meeting, undignified promotional methods and/or materials considered to be objectionable (in Wellvana Health, LLC's sole discretion) are expressly prohibited. Outside food and beverages are expressly prohibited. Any private social functions hosted by Company must be scheduled at a time and place

where it will not conflict with official Event activities.

6. Sponsored Event Communications – Sponsors will not excessively send solicitous messages to conference registrants. Wellvana Health, LLC prohibits sponsors from sending any solicitous advertising to conference registrants prior to the event.

7. Representations; Warranties.

- a. Each party represents and warrants to the other party that: (i) it is duly organized, validly existing, and in good standing under the laws and regulations of its jurisdiction of incorporation, organization, or chartering; (ii) it has the full right, power, and authority to enter into this Agreement; (iii) the execution of this Agreement by its representative has been duly authorized by all necessary corporate actions; and (iv) when executed and delivered by both parties, this Agreement will constitute legal, valid, and binding obligations of the parties.
- b. Company represents and warrants that: (i) it will not promote a Wellvana Health, LLC competitor (or a service that is competitive to those offered by Wellvana Health) at the Event; (ii) it and its employees have not been: (A) excluded from participation in any federal health care program; or (B) debarred, suspended or otherwise excluded from participating in any federal or state procurement or non-procurement program or activity, and to the best of its knowledge, there are no pending or threatened governmental investigations that may lead to such exclusion; and (iii) it owns or has a license right to promote the products and services it will promote at the Event.

8. Term; Cancellation; Termination.

- a. The term of this Agreement will commence as of the date it is signed by the parties and, unless terminated earlier pursuant to an express provision of the Agreement, will continue thereafter until June 1, 2026 ("Term").
- b. This Agreement may be terminated as follows:
 - i. with written notice, subject to a ten (10) calendar day cure period (measured from the date the non-terminating party first received notice of its alleged breach), a party may terminate this Agreement without penalty should the other party fail to pay all amounts owed when due;
 - ii. with written notice, subject to a thirty (30) calendar day cure period (measured from the date the non-terminating party first received notice of the alleged breach), a party may terminate this Agreement without penalty should the other party breach a material obligation arising under this Agreement.

9. Acknowledgements. All sponsorships for the Event are approved in Wellvana Health, LLC's sole discretion. Wellvana Health, LLC: (a) does not guarantee or represent that this sponsorship will be exclusive to Company, in any manner; and (b) reserves the right, in its sole discretion, to exclude or eject Company from the Event for its breach of this Agreement. The venue hosting this Event may impose additional requirements on your participation, including, but, not limited to, a minimum insurance requirement or additional forms that must be completed. Additional information will be provided if applicable.

10. Definitions.

- a. "Agreement" collectively refers to the Sponsor Contract, these Terms and Conditions, and the Conference Sponsorship Options attachment.
- b. "Event" refers to the 2026 Accountable Care Symposium Presented By Wellvana Health, LLC.
- c. "Marks" collectively refers to the applicable party's artwork, trademarks, trade names, service marks, designs, logos, domain names, and/or any other indicators of the source or origin of any product or service.

11. Miscellaneous. The relationship between the parties is that of independent contractors. Nothing in this Agreement shall be construed as creating any agency, partnership, joint venture, or other form of joint enterprise, employment, or fiduciary relationship between the parties, and neither party shall have authority to contract for or bind the other party in any manner whatsoever. This Agreement constitutes the entire agreement between the parties with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject matter. Neither party may assign or otherwise transfer any of its rights or obligations under this Agreement without the other party's prior written consent. This Agreement may be executed in counterparts, each of which is deemed an original, but all of which together are deemed to be one and the same agreement. A signed copy of this Agreement delivered by email or other electronic means, including, but, not limited to, copies that are signed via electronic signature, shall be deemed to have the same legal effect as delivery of any original signed copy of this Agreement.
